Product specification

Cannaline CBD TEA – MEMORY & FOCUS

General information

General characteristic: herbal tea produced by blending according to a recipe.

Ingredients list: Verbena (*Verbena officinalis*) 25%, green tea (*Camellia sinensis*) 24%, ginkgo (*Ginkgo biloba*) 15%, rosemary (*Rosmarinus officinalis*) 10%, heather (*Calluna vulgaris*) 10%, hemp seed (*Cannabis sativa*) 10%, wild marjoram (*Origanum vulgare*) 5%, hemp leaf (*Cannabis sativa*) 1%.

Note: Cannabis sativa - technical quality.

Packing: paper boxes contain 20 tea bags with tag.

Weight: netto 30 g (20 x 1,5g tea bags).

Shelf-life: 24 months with appropriate storage.

Storage condition: normal storage condition – dry place, temperature – max 25°C.

Preparation and dosage: infuse with boiling water only and leave to infuse for 15 min, dosage 1 tea bag per day.
